Re: Angel Bay Seals

Dear Cllr Roberts, Dilwyn,

I am writing to ask you to consider bringing forward a voluntary Code of Conduct for water vessels / recreational boats in the Angel Bay area, by Llandudno's Little Orme.

As you may be aware, there is a sizeable population of seals who make their home here. While this is a wonderful attraction for locals and tourists alike, I am concerned that the actions of a few may be causing some harm to the species.

During the pupping seasons (early August – late October), the seals are especially vulnerable. A voluntary Code of Conduct would seek to ensure that boats slow down gradually to a minimum speed when encountering seals, (or dolphins, porpoises, etc.) and that extra care is taken to avoid disturbing animals with young.

A similar scheme has been in place in Ceredigion since 1992, and has proved both successful and popular. More details of this can be found at: <http://www.cbmw.org/wildlife/code-of-conduct/>

Extending the Code of Conduct to include walkers and dog owners, to prevent them disturbing the seals on land, would be beneficial to all parties also.
