

FREEDOM OF INFORMATION REQUEST X04-44

We refer to your email dated 5 April 2018 which contained a request for information as set out in italics below. Following consideration of your request, in accordance with the Freedom of Information Act 2000, I respond to each point as follows:

The Authority only holds internet access logs for four rolling weeks, so the response below is for last two weeks of March 2018.

a. The amount of time spent by staff on social media websites on work ICT equipment.
The Authority does not record time spent on websites.

b. The number of attempts that were made by staff to access pornographic sites on work ICT equipment.

12 attempts were made and blocked to the category Pornographic Material. All 12 were incorrectly categorised and we not pornographic.

b. The number of attempts made by staff to access blocked sites: pornographic and not pornographic; on work ICT equipment

571845 attempts were made and blocked against all blocked categories.

I hope this response satisfies your request. If you are dissatisfied with the handling of the request, under the Freedom of Information Act 2000 you have the right to request a review of the Council's response to your request for information. If you wish to request a review, please write to:
