Thank you for your request for information dated **05/04/2018** concerning **ICT Usage**

This is to inform you that your request has been considered and I can provide the following response:

The Request:

For the financial year of 2017/18, please provide:

a. The amount of time spent by staff on social media websites on work ICT equipment.

This information is not recorded.

b. The number of attempts that were made by staff to access pornographic sites on work ICT equipment.

31858647 – Please note - Our Web blocking software will block any attempt to access parts of a web site which may fall into any of our blocked categories, example adverts. Additionally accessing just one website will generate multiple “hit” requests, as each part of that request will attempt to access different resources that make up the site. One Website request can generate over 100 hits. We are recording the total number of hits not the total number of individual website requests, we do not record that information.

It is anticipated the 99% of the above attempts were unknown to the user and were background resources for the website they might have been on, again, example adverts. Therefore the figures given do not represent a true figure of attempted access to sites that may be blocked.

c. The number of attempts made by staff to access blocked sites: pornographic and not pornographic; on work ICT equipment
