Dear Chief Executive, Gary,

I am writing with regards to the future of the park and ride facility at Glan Clwyd Hospital. As you and the Minister for Health and Social Services are already aware concerns have been raised with me by constituents and medical professionals with regards to the parking situation at Glan Clwyd Hospital.

Whilst I welcomed the fact that the provision of the facility was extended until 31 October 2019, and that different ways of easing parking pressure on site would be considered in the meantime, I would be most grateful if you could now explain what the potential solutions considered were, and which you have chosen to pursue.

Personally, I am aware that all who have contacted me would be delighted should the park and ride service remain permanently. However, should this be financially difficult, I would implore you to note that some residents have spoken about the possibility of providing the service at peak times only, and even charging £1 for a return ticket.

One reason why this service needs to be saved is that users of onsite parking facilities have told me that patients are often left with no option but to wait for someone to vacate a space, or park unsafely in inappropriate locations so to not miss appointments.
